

ARTICLES OF INCORPORATION

OF

**TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC.,
a Montana nonprofit, mutual-benefit corporation**

ATIS, LLC, a Montana limited liability company, for the purpose of forming a mutual benefit corporation under the Montana Nonprofit Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC.

ARTICLE TWO

The corporation is a nonprofit, mutual benefit corporation.

ARTICLE THREE

The purpose of the corporation is for the management of the TREE LINE CONDOMINIUM as described and established in that certain DECLARATION FOR THE TREE LINE CONDOMINIUM and BYLAWS OF THE TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC. recorded or to be recorded in the office of the County Clerk and Recorder, Gallatin County, Montana and as subsequently amended (the

"Declaration and Bylaws").

ARTICLE FOUR

The street address of the corporation's initial registered office is 7555 Cottonwood Road, Bozeman, Montana 59718. The mailing address of the corporation's initial registered office is PO Box 11530, Bozeman, Montana 59719. The name of the corporation's initial registered agent at such address is BEN NISTLER.

ARTICLE FIVE

The name and address of the incorporator is: ATIS, LLC, a Montana limited liability company, of PO Box 11530, Bozeman, Montana 59719.

ARTICLE SIX

The corporation will have members. The members of the corporation are those persons who qualify for membership in the TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC. as provided for in the Declaration and Bylaws. Each owner of a unit within TREE LINE CONDOMINIUM must be a member. The voting rights of each member are set forth in the Declaration and Bylaws.

ARTICLE SEVEN

The corporation has designated directors. The designated directors of the corporation are those persons who are directors of the TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC. as provided for in the Declaration and Bylaws. The term for the corporation's board of directors is the same term for the directors of the TREE LINE CONDOMINIUM OWNERS ASSOCIATION, INC. as provided for in the Declaration and

Bylaws.

ARTICLE EIGHT

These Articles of Incorporation may be amended by the members by two-thirds of the votes cast or a majority of the voting power, whichever is less. So long as the incorporator or its successors and assigns owns a Unit within TREE LINE CONDOMINIUM, an amendment of these Articles of Incorporation must also be approved in writing by the incorporator or its successors and assigns.


ARTICLE NINE

Upon dissolution or other termination of the corporation, the assets of the corporation shall be distributed to an organization or association composed of the Unit Owners of the TREE LINE CONDOMINIUM. If no such organization or association exists, then said assets shall be distributed to the individual Unit Owners of the TREE LINE CONDOMINIUM pursuant to the terms of the Declaration and Bylaws and the Montana Unit Ownership Act. The corporation may be dissolved by the members pursuant to the terms and conditions for dissolution of the Tree Line Condominium as set forth in the Declaration and Bylaws.
